While at a camper at Bikefest Captain Liz Croley and Deputy Chris Kines was dealing with a trespass type incident when a fight ensued between Mike Green and his wife (neither Deputy witnessed this altercation). At the time of the incident Deputies were not aware of the incident between Mike Green and his wife. Deputies did witness Mark West and Mike Green in an altercation. Mark West was detained with resistance from him. After the altercation Mark West stated " Mike Green and his wife was fighting and he was trying to stop it, when they all started hollering and I fought with the deputies and should not have".

Once Mark West was detained his step son Ronnie Aaron Parrish saw the officers taking his father away and walked over to Captain Croley and struck her in the chest. Deputy Wade Umbach, Bikefest security Macon Moore and a citizen Norma McIntyre witnessed Ronnie Aaron Parrish strike Captain Croley in the chest. Deputies were attempting to place Ronnie Aaron Parrish under control when Parrish attempted to grab Deputy Umbach's service weapon. Captain Chip Nix, witnessed Deputies struggling with Ronnie Aaron Parrish and heard a deputy (not sure which deputy), say " don't try to get his gun boy" after hearing this statement, Captain Nix attempted to locate an area to try to dry stun tase Ronnie Aaron Parrish and was unsuccessful. Deputies fought with Ronnie Aaron Parrish at a campsite in between a camper and trailer. After speaking with Bikefest Security Lynn Webb he stated that he had been trying to keep Ronnie Aaron Parrish back and was unsuccessful. Captain Croley contacted EMS to check Ronnie Aaron Parrish's wounds and cleared him. Carla Parrish, wife of Ronnie Aaron Parrish later showed up to remove him from Bikefest grounds. Carla Parrish is a RN and stated that he was ok; Major Wendell Cofer suggested that he go to the ER in Bainbridge, GA. Carla Parrish stated that she would take him to the ER instead of the Sheriff's Office calling EMS to transport him.

Bikefest Securty Lynn Webb, asked the offender Mike Green to leave the premises, when Mike Green became irate and struck the trailer next to him causing Linn Webb to move to avoid being hit. Mike Green stated "this is bullshit" Deputy Chris Kines told Mike Green to put his hand behind his back he was under arrest. Mike Green resisted arrest and other Deputies assisted in handcuffing Green. Mike Green refused to calm down and continued to resist after he was handcuffed. Alachua County RN cleaned Mike Green wounds and medically cleared him.

Mike Green, Ronnie Aaron Parrish, and Mark West were all moved from the location of the campsite and relocated to the Sheriff's Office command center. While at the command center Mike Green stated "Bikefest security told him and his wife to leave because they were arguing and he refused to leave", he also stated that he fought with the Deputies and should not have fought with them. Mike Green, Ronnie Aaron Parrish, and Mark West were asked to leave Bikefest grounds, their armbands were removed. Mike Green's mother came and picked him up from Bikefest grounds at the Sheriff's Office Command Center. Ronnie Aaron Parrish's wife Carla Parrish picked him and Mark West up from the Bikefest grounds at the Sheriff's Office Command Center
